10) Trustee can present any body who entere the house /compound of trust with any beneficiaky interest and trsutee have the rights not to speak the cause of present if asked so.

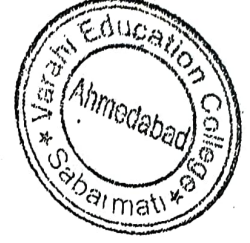
11) To fulfill the aim and objection of their institution the trust can appoint any person. On remeunation based . The loan facility can be provided through trust, can do necessary expenses.

- (f) Chairman/M.T. is authorised to accept monthly salary or any yearly award in lieu of rendering his services to the trust as confirmed by trust.
